DEPOSITS

A puppy can be reserved and held with a minimum deposit of 25% of the value of the puppy. The deposit is non-refundable and non-transferable if the buyer defaults on the purchase of the puppy. Hotshot Bulldogs will refund the full deposit only if the puppy cannot be sold due to serious illness or death.

To hold a puppy, the buyer agrees to send an overnight wire transfer, Zelle, cash, a priority U.S. Postal Money Order, cashier's check, or Walmart money gram in the minimum amount of 25% of the value of the puppy within 72 hours. The puppy will be placed on "Hold" while awaiting the deposit. Once the deposit is received, the said puppy will be marked and considered "Sold." If the deposit is not received within 72 hours, the puppy will be placed back up for sale. A signed and dated copy of this Contract/Guarantee must accompany the deposit within 72 hours, or the puppy will be put back up for sale.

PAYMENT

Full payment for the puppy is due when the puppy reaches 6 weeks of age. Final payment must be made with a cashier's check, a U.S. Postal money order, a Walmart money gram, or cash deposited into Hotshot Bulldogs Inc Wells Fargo account. The puppy WILL NOT be shipped until the check has cleared the bank. Full payment, along with a signed and dated Contract/Guarantee, must be received by Hotshot Bulldogs before shipping is scheduled. If the puppy is not paid for in full and/or still remains at Hotshot Bulldogs at 9 weeks of age, all monies paid will be forfeited, and the puppy will be placed back up for sale.

SHIPPING

If the buyer is unable to pick up their puppy in person, the puppy may be flown to a nearby airport anywhere in the continental USA, pending airline restrictions. The price of air transportation is determined at the time of delivery based on the actual cost of air flight, gas, crate, and health certificate. Ground transportation is another option for shipping. The buyer understands that the puppy may be predisposed to certain health conditions during shipping. Hotshot Bulldogs is willing to assist the buyer in arranging puppy transportation but is not liable for the puppy once it leaves our home.

REQUIREMENTS

Hotshot Bulldogs agrees to provide the buyer with the necessary health information, including all shots and deworming records.

Hotshot Bulldogs agrees to furnish the buyer with the AKC registration application once it is received from the Registry.

PUPPY HEALTH CHECK GUARANTEE

Hotshot Bulldogs guarantees the puppy to be in good health, to the best of our knowledge, and that it has been examined by our veterinarian before leaving our home. For this health guarantee to become effective, the puppy must receive a complete health physical by a licensed veterinarian within two days of delivery to the buyer. Failure to do so voids the Health Guarantee. All veterinary expenses are the responsibility of the buyer. If the buyer's veterinarian finds said puppy to have a life-threatening condition, the buyer must inform Hotshot Bulldogs.

On the same day as the diagnosis. A diagnosis of viral/bacterial infection, kennel cough, coccidia, giardia, intestinal worms, fleas, mites, and other parasites are treatable and not considered life-threatening. Hotshot Bulldogs must receive a copy of the examination report by mail or email within one week of the exam, or the extended Health Guarantee is void.

EXTENDED CONGENITAL GUARANTEE

Hotshot Bulldogs guarantees the puppy to be free of any genetic/hereditary defects that cause death or serious impairment of vital functions, which would prevent the puppy from being a normal family pet before the age of one year. Upon the discovery of a life-threatening genetic untreatable condition, the buyer must inform the seller in written format within three days of diagnosis. Full medical documentation must explicitly and singularly identify that the cause of the puppy's condition is genetically related. This documentation, along with all radiographs and test results, will be evaluated by a veterinarian chosen by the seller to confirm and authenticate the results provided by the buyer's veterinarian. In the event of death, the buyer must have a necropsy performed and contact the seller within 24 hours of death, and the report must be faxed to the seller's veterinarian within three days. The findings and opinions of the seller's veterinarian are to be considered the final and ultimate opinion. Hotshot Bulldogs does not agree to compensate the buyer for any veterinarian expenses and does not offer cash refunds.

If the seller's veterinarian finds said puppy to have an untreatable life-threatening genetic condition, the seller will contact the buyer, who will then have five days to return the puppy and registration papers to the seller. Hotshot Bulldogs will replace the puppy with another of the same sex as soon as a comparable puppy becomes available. Failure to return the defective puppy to the seller within the stated time frame voids the replacement of another puppy. The replacement puppy fulfills this contract and does not offer any further guarantee. All transportation expenses related to the original puppy as well as the replacement puppy, are the sole responsibility of the buyer.

Although a conscious effort is made by Hotshot Bulldogs to breed and produce sound, healthy bulldogs, the buyer is aware and understands that due to the nature of this breed, bulldogs are predisposed to certain breed-specific issues that are NOT guaranteed, including cherry eye, stenotic nares, entropion/ectropion, loose knees and

hips, skin allergies, dermatitis, demodectic mange, immune deficiency, thyroid dysfunction, small trachea, elongated soft palate, inguinal and umbilical hernia, and other common bulldog breed ailments. This guarantee excludes any breed-specific issues that are considered normal or common for the bulldog breed, which are preventable/treatable/manageable by medication and/or surgery and are not considered life-threatening congenital defects. We do not breed dogs with undesirable conditions, but we cannot guarantee that previous generations did not have these conditions in their lines. Therefore, we cannot guarantee that these conditions will not show up unannounced in future litters. It is also very important to have a veterinarian knowledgeable about the bulldog breed.

At the time of purchase, the puppy will be current on all deworming's and vaccinations according to age. The buyer agrees to keep all vaccinations & deworming's current, including rabies, and to provide regular heartworm preventative as prescribed by their veterinarian. The buyer also agrees to keep the puppy/dog in humane conditions, providing proper socialization, medical care, food, water, and an air-conditioned shelter. This guarantee will be completely null and void if the said pup is used for any sort of illegal activity (i.e., dog fighting) or in any extreme sports (i.e., weight pulling), or if it is mistreated, abused, or not taken care of.

We represent our puppies as being suitable as pets only. We make no claim that they are suited as breeding or show animals, and we offer no compensation for circumstances or characteristics that limit the dog's ability to be bred or competitively shown, regardless of the type of AKC registration. There is NO guarantee on the color, height, or weight of a puppy upon maturity. If applicable, the seller will provide DNA color test results from the performing lab but is not liable for incorrect lab testing results.

The buyer attests to being at least 18 years of age and that this is a legal and binding contract between the buyer and the seller. The buyer also attests that they have thoroughly researched the Bulldog breed and understand the many health issues they can possess, including those excluded from this Health Guarantee. This Contract/Guarantee is not transferable to any other party. The buyer agrees to pay any and all attorney, court, and other fees incurred in settling any dispute, with the place of venue and jurisdiction being in Los Angeles County, California.
